#### 2022-23 Where we are Today

- Last 2 years we have appropriated approximately \$900,000 of fund balance –
  we have not used any.
- 22-23 Planned operating deficit (Appropriated fund balance) \$955,000. Currently projecting not using any fund balance.
- What does this mean? We will have funds to build our reserves.

2023-24	Approximately 1.18%	

#### Budget Development- Personnel

- Salaries
  - All contracts (WTA, WAA, CSEA) are settled. No surprises.
  - 2 teacher retirements resulting in "breakage"

#### **Budget Development- Benefits**

 Health Insurance – we are anticipating a double digit increase in both CDPHP and EMPIRE

#### **Budget Development-Transportation**

- New Bus quote = \$95,000 increased from \$60,000 in 2022
- Durham contracts increase by CPI

### 2022-23 budget: FEDERAL FUNDING

Outside the General Fund Budget: ARPA continues for 2023-24 school year. CRRSA ends 9/30/23.

- Part Time Social Worker (.6FTE) Through BOCES
- Afterschool Support in Elementary School
- Additional technology (student chromebooks)
- 2 Full Time High School Teachers (Math and ELA)
